**Suggested Specification**

Model PG8SBFSL shall deliver 8.0 gph of 50°F water at 90°F ambient and 80° F inlet water per ASHRAE 18 testing. Shall include the VersaFiller Bottle Filler with mechanical activation; lower units shall have four push pads to activate the manual flow of water for the cooler. Bottle Filler alcove and cabinet finish shall be stainless steel. Key VersaFiller components contain Freshield®, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew. Basin shall be designed to eliminate splashing and standing water. Water saver bubbler reduces waste water by 50% and shall operate between 20 and 100 PSI. One-piece low flow vandal resistant chrome plated solid construction metal bubbler keyed into place to prevent vandalism. Shall use R-134a refrigerant. Shall comply with ANSI 117.1 and ADA. Shall be listed by Underwriters Laboratories to US and Canadian standards. Shall comply with NSF/ANSI 61 and NSF/ANSI 372.
