## Suggested Specification

Model PGV8EBFSL-14G shall deliver 8.0 gph of 50°F water at 90°F ambient and 80°F inlet water per ASHRAE 18 testing\*. Model PGVEBFSL-14G is a non-refrigerated model and delivers ambient drinking water. Shall include the VersaFiller® with contactless activation and laminar flow. Bottle filler alcove and cabinet finish shall be stainless steel. Key VersaFiller components contain Freshield, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew. Cabinet & basin shall be 14 gauge stainless steel, with a heavy duty galvanized frame, with galvanized steel screens to prevent objects from being inserted into ventilation panels or underside of unit. Each fountain shall include a single vandal resistant push button to activate the flow of water. Basin shall be designed to eliminate splashing and standing water. One-Piece low flow vandal resistant chrome plated solid construction bubbler keyed into place to prevent vandalism. Water saver bubbler to reduce waste water by 50% and shall have flexible guard and operate between 20 and 100 PSI. Shall use R-134a refrigerant. Shall comply with ANSI 117.1 and ADA. Shall be listed by Underwriters Laboratories to US and Canadian standards, and comply with NSF/ANSI 61 and NSF/ANSI 372.
