## MODEL PWFSVBF

### Suggested Specification

When retrofitted to either the PG8AC or P8AM, the PWFSVBF bottle filler has independent electro-mechanical push button activation and laminar flow. All exterior bottle filler cabinet and drip tray shall be 18 gauge stainless steel. Key plastic components contain Freshield®, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew. Unit shall include filter monitor and bottle counter. When retrofitted to either the PG8AC or P8AM the bottle filler model satisfies ANSI A117.1 and ADA requirements when properly installed. Units also meet guidelines for children's accessibility providing the floor to orifice height is 30 inches and proper clear floor space is provided for frontal approach. Shall be listed by Underwriters Laboratories to US and Canadian standards. Shall comply with NSF/ANSI 61 and NSF/ANSI 372.

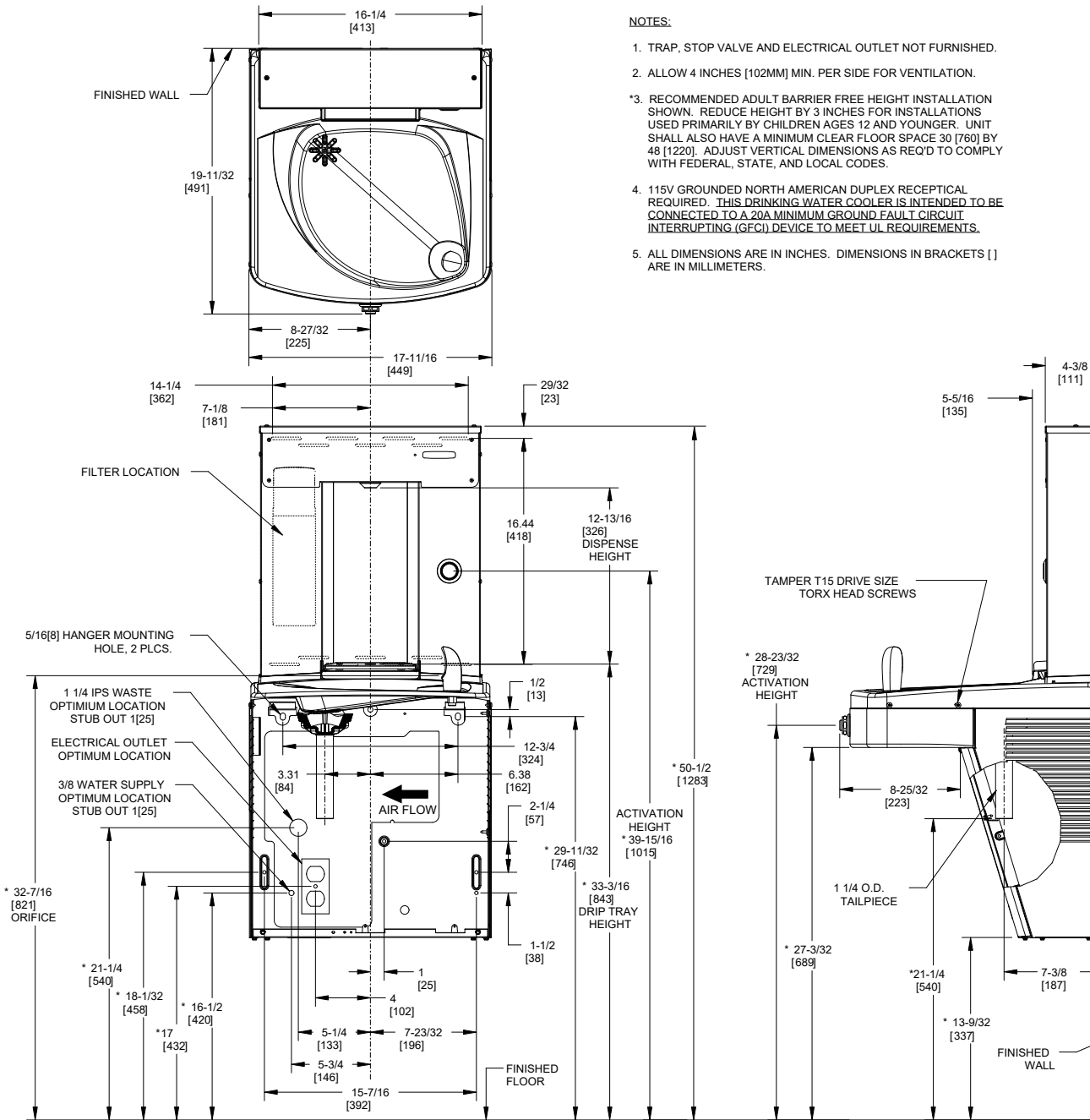
